The operations of the Registrant for the quarter ended June 30, 2007 will consist almost entirely of the operations of Broadband Maritime, Inc., the Registrant's wholly-owned subsidiary acquired in the merger reported in the Registrant's current report on Form 8-K filed April 5, 2007. Those operations are completely changed from the business operated by the Registrant in the same quarter in 2006. On June 5, 2007, BBM Holdings announced that Broadband Maritime, Inc. had ceased operations and reduced employment to a small residual force. The Registrant committed to this action following a meeting of the Board of Directors on May 31, 2007. Given our limited resources as referenced in Part III of this Form 12b-25, a reasonable estimate of the results cannot be made.
